- 4 private offices

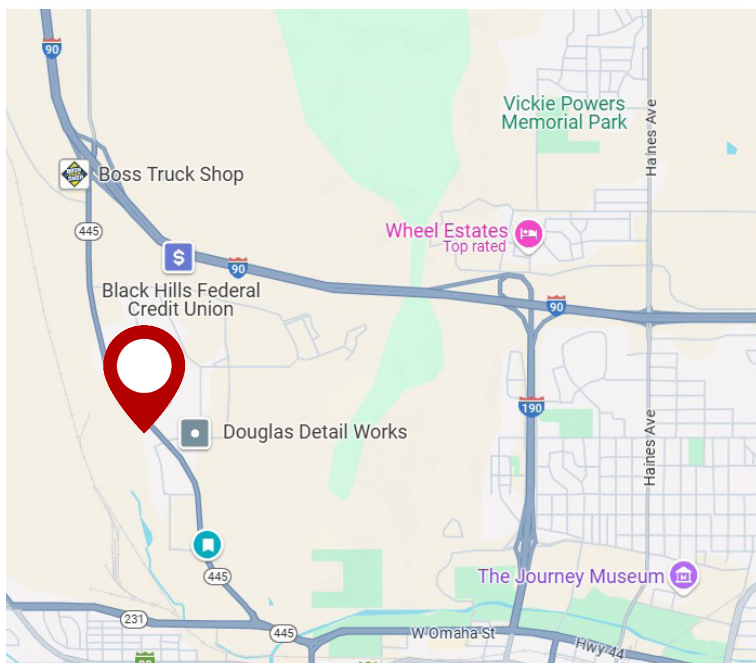
Warehouse Building (3,328 sq. ft.): Previously utilized for cold storage, this building offers great functionality with:

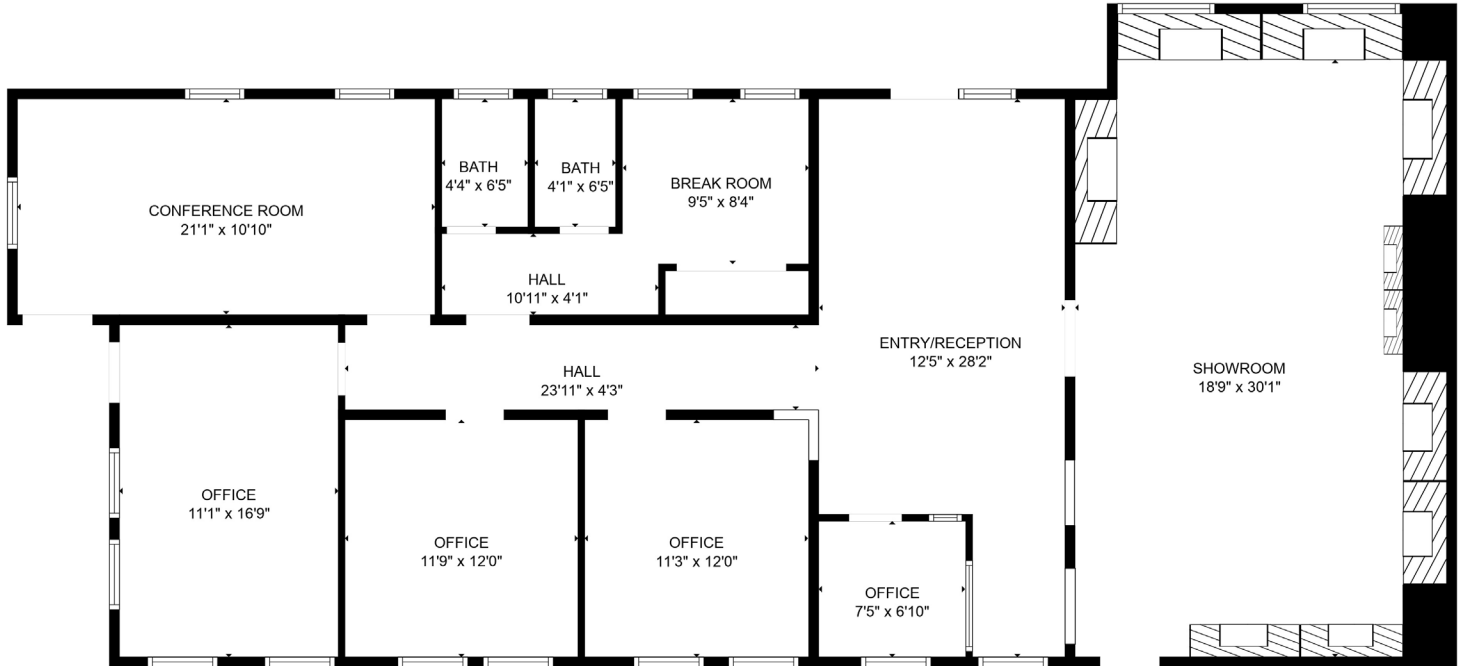

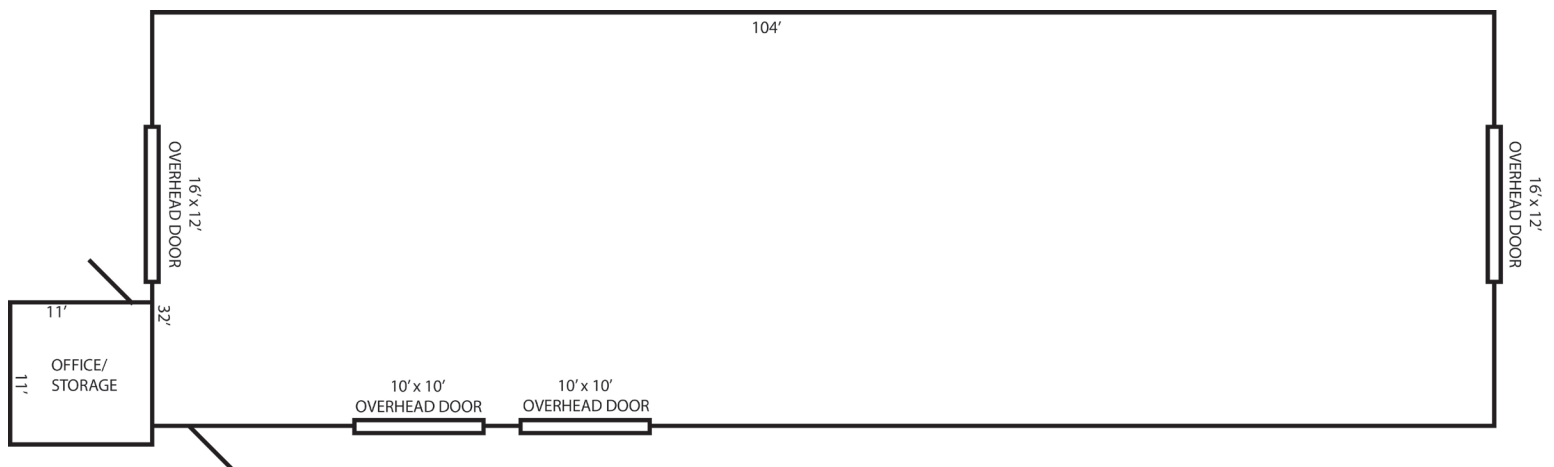
