PROPERTY OVERVIEW

Hard to find distribution warehouse located in southeast Rapid City. This 11,658sf building has 10 oversized (20x14) grade level overhead doors, 5 dock high doors with levelers and 2 delivery vehicle extensions providing an additional 26 delivery height doors (removable if not needed). The 2.14 acre lot allows for easy truck access and plenty of room for employee parking. The interior office space has 3 small offices and 2 bathrooms upstairs with a break room and receiving office on the main level. The warehouse space contains floor drains and a large commercial conveyor running through the center of the building that allows for easy distribution and loading.






